Fee Outline for International Adoption Programs—China Regular and Special Needs Adoptions

(Note: Home study and post-placement fees vary by state and by agency.

Home study fees can range from \$1000-\$3500, depending on your state or agency).

If you are in Utah, we can do your home study and post-adoption reports. Ask about our current fees.

If you are in another state, we can help you find a home study agency.

Home study and post-placement visits are required for all adoption programs.

China requires post-placement reports at 6 and 12 months after placement with 100% compliance.

These reports should be paid for before you travel to China to adopt.

- \$5,000—West Sands Adoptions agency fee
- \$149—Adoption education course, “Because They Waited”
- \$4—Culture Gram on China
- \$750—Homeland Security with I-800A
- \$80—Per adult in your home for FBI fingerprinting
- \$800—State authentication (approximate)
- \$500—FedEx fees for sending dossier for authentications and forwarding to China (approximate)
- \$2350—Dossier translation/registration fee
- \$1000—Legal Fees in China
- \$5050—Orphanage donation and wire transfer fee
- \$1500—Hotels, meals and local transportation in China for 2 parents and child
 - \$200—In-country flight
 - \$500—Spending money in China
 - \$600—Provincial Adoption Service
 - \$400—US visa for your child
- \$1200—Beijing Tour (optional)
- \$2700—Approximate costs for 2 parents’ flights to China and return with child
- TOTAL: \$22,783**

Note: China’s regular program is a program with a long wait, which may require re-authenticated home study updates or updates with Homeland Security. You will be responsible for fees for document updates.

International travel requires you to have a current passport. Please be sure that your passport is more than a year away from expiration when you complete your dossier. If you have never obtained a passport, the current fee for new passports is \$97. You will also be required to submit passport photos (approximately \$15).

Also: Most of your international case fees can be paid directly to West Sands Adoptions. The agency fee is due when you sign with us. The other fees can be paid as they are incurred. We take care of document authentication to save you some stress in your paper chase. However, we will ask you to set up your own FedEx account to make the authentication process more efficient for you. Your China orphanage donation and legal fees must be wired to China by Western Union.

Fee Understanding

I/We understand that this fee outline is only an approximation or estimate of fees that are **currently** in place and those fees can change at any time without warning or reason during the adoption process. I/We understand that West Sands Adoptions cannot be responsible for any adoption disruption, failed placement, or *for any kind* of fee changes brought about by *and not limited to* government instability, natural disaster, civil unrest, crooked bureaucracy, cultural differences, or prejudices of any kind. I/We agree to hold West Sands Adoptions blameless for any changes to this fee schedule.

If at any time during the process, unexpected fees become necessary, West Sands Adoptions is authorized to make payments to cover those fees and bill our account, only if those fee amounts are less than \$1000. West Sands Adoptions must contact us before making additional fee payments over \$1000.

West Sands Adoptions will give the Client Family an itemized accounting of all fees and expenses to be paid with an explanation in writing of our refund policy if services are not completed, and will provide the client such refund, if any, within 60 days of completion of services or it is evident services will not be provided.
